EDUCATIONAL SAVINGS ACCOUNT.

One of the most exciting times things that has ever happened for Saint Albert is the educational saving accounts.

What this is that any new student who will attend Saint Albert in the fall is eligible for an educational savings account in the amount of \$7600.00. This money applied to tuition will pay for most the tuition at Saint Albert. There are various levels of tuition depending on what class the student is in. This can be explained by the Saint Albert administration.

The other way to qualify for the Educational Saving Account is based on the number of members in your immediate family and 300 percent of the poverty level. We will have a presentation on these numbers very soon in the parish. A simple example is this that a family of four would be \$90,000.00. If the family makes less than this \$90,000.00 the children would qualify for the Educational Savings Account. Another example is that a family of six would qualify for the educational savings account if there income was less than \$121,000.00.

In three years every student at Saint Albert will qualify to receive the \$7600.00 Educational Savings Account.

This is a very exciting time for Saint Albert because the tuition cost for Saint Albert will never be an obstacle for a student to attend Saint Albert. We will have a presentation for the Educational Savings Account in the parish.

Diocesan Appeal.

This is sounding like a broken record but we are still \$37,000.00 away from our goal. In all my years here we never have been this far away from our goal. If you have not made your pledge please do so. If we do not make our goal we will have to make up the deficit by paying from our general fund. Thank for your generosity to the appeal.

Month of May.

The month of May is dedicated to the Blessed Virgin Mary. I am very pleased that the Altar Society will lead the rosary before each of the masses. I encourage everyone to take advantage of this time to pray the rosary with the members of our parish and make the month of May a true time of prayer with the Blessed Virgin Mary.

Parish Council Members.

I do not have any volunteers to serve on parish council. I hope that four people will volunteer to be on the council. It will be one of the best decisions you have ever made. !!!!

Hip Replacement Surgery.

I will be having hip replacement surgery this Wednesday at Mercy Hospital. I do not know how long my recovery will be but I hope in three weeks that I will be able to resume many of my tasks. The daily masses will continue during my absence on their regular schedule. Father Dean will be praying the week day and Sunday masses.

Please pray for me as I hope my recovery will be much quicker than the doctor is telling me.

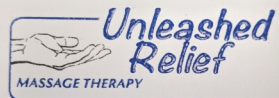
